

## **CONTEST RULES**

This document fully and clearly sets out contest rules for the Bratislava Divoká Voda Weekend, Multisport Card for Two and €50 Voucher at KOBE Restaurant Contest (“Contest”). These rules may be changed only by written addenda.

The contest is organized by:

### **I. Date and Time of the Contest:**

1. The contest runs in the Slovak Republic (“Contest Venue”) from midnight on April 1, 2017 to one minute before midnight on April 30, 2017 (“Contest Period”).

2. The actual contest takes place online.

### **II. Contestants**

1. Contestants may only be individuals older than 18 years of age who are either participating in Erasmus+ or in another international bilateral university exchange study program (“Contestant”) during the Contest Period.

2. Anyone employed by or in any other type of work contract with the Organizer, or with companies or agencies cooperating with the Organizer, or close relatives of such persons, is ineligible to enter the contest. A close relative is considered to be any of the persons mentioned in Sec. 116 and 117 of Act No. 40/1964 Coll. The Civil Code, as amended (“The Civil Code”).

3. Anyone not meeting the conditions to be a Contestant and Contestants who act in contrary of the Contest Rules will be declared ineligible. Any person meeting the conditions for winning a prize who is declared ineligible (e.g. because of having provided false information), will be disqualified from the Contest and has no claim to receive any prize. In such a case, the Organizer is entitled to award the prize to the highest runner-up or to use it for other marketing purposes. Contestants will be disqualified if the Organizer finds or justifiably suspects that any Contestant or somebody else helping the Contestant to win a prize has committed fraud or unfairly colluded with the Contestant.

### **III. Contest prizes and their awarding:**

1. The following prizes will be awarded:

1st Prize:

Weekend at Divoká Voda including accommodation in a four-person bungalow and the following attractions: rafting, stand-up paddling, volleyball;

2nd Prize:

Two free one-month Multisport Cards for free admission to more than 250 sports and recreation centers;

3rd Prize:

Voucher worth €50 at KOBE Restaurant

(“Prizes”)

2. Prizes may be claimed by the winner from the Contest Co-organizer at Comenius University in Bratislava, Šafárikovo námestie 6, 814 99 Bratislava, Slovakia; Contact Person: Matej Bednár, cu.president@esn.sk

3. Winning contestants will be notified by e-mail within seven (7) working days of the determination of winners and such notification will be sent to the e-mail address entered by the Contestant in his/her contact details. This announcement e-mail may provide more information and instructions about acknowledging receipt and also about how to receive the prize, and the winner is required to follow these instructions.

4. If the winner fails to confirm his/her acceptance of the prize within seven (7) days of notification as a winner or does not accept the prize under the conditions mentioned in the prize announcement e-mail which the Organizer has sent, the winner will thereby forfeit the prize to the Organizer.

5. The Organizer reserves the right to request, in case of doubt, proof of eligibility (such as an identification card for the purpose of determining the age of the Contestant, confirming participation in an internship or study in Erasmus+ or any bilateral university exchange program in Slovakia) from a Contestant entering the Contest or a Contest winner. Any Contestant that fails to submit what the Organizer considers proof of eligibility will be disqualified from the Contest. In such a case, the prize will be forfeited to the Organizer without any compensation and the Organizer will then be entitled to award the prize to another Contestant or to use it for other marketing purposes.

#### **IV. Contest mechanics and determination of winners:**

1. Contestants enter the contest during the Contest Period by uploading a contest video between 30 and 180 seconds long on *5 Things That Make Me Love Bratislava* ("Contest Video") through web wetransfer.com to reach the Organizer of the Contest at [foltyn@visitbratislava.com](mailto:foltyn@visitbratislava.com)

2. The Contest Video must be in vlog format and meet the criteria below:  
Minimum resolution: 720p – 1280 x 720 pixels (16:9), minimum 25 slides per second  
Format: MP4, AVI, MOV, MPEG  
Postproduction: yes  
Language: either English or native language

3. The Contest Video must be free of defects, including errors in law, and be in accordance with the applicable laws of the Slovak Republic. The Contest Video may neither prejudice, damage nor adversely affect the rights and legitimate interests of third parties, failing which the Contestant is liable for any and all damage thereby caused to the Organizer and/or third parties.

4. Along with the Contest Video, Contestants are required to submit the following contact details: full name, e-mail address, country of origin and name of the school where the Contestant is studying in Slovakia through Erasmus.

5. By forwarding a Contest Video, a Contestant gives to the Organizer his/her agreement to the rules of the Contest and consent to the processing of personal data.

6. The Contestant's participation in the Contest is construed as granting to the Organizer a free and nonexclusive license to use the Contest Video in promoting and providing information about the city of Bratislava, Erasmus and the Erasmus Student Network Slovenská republika. The Contestant grants this license for an unlimited time and with no geographical limitation. The Organizer may grant a sublicense for use of the Contest Video to present Bratislava without requiring the permission of the Contestant to do so.

7. Contestants are entered in the Contest from the moment when the Contest Video and contact details are received.

8. Determination of winners:

a) Three prizes will be awarded in the contest (see Art. III Paragraph 1 of these rules).

b) Winners will be determined on May 5, 2017 by a panel composed of two (2) judges named by the Organizer and two (2) judges named by the Co-organizer. The judges will take the following criteria into account in evaluating the Contest Videos: chosen location, creative processing and total video quality.

#### **V. Processing and protection of personal data:**

By sending the Contest Video, the Contestant gives his/her consent to these rules and undertakes to comply in full with them. Furthermore, by sending the Contest Video, the Contestant grants permission to the Organizer, either alone or through an intermediary, to process all personal data related to the Contestant and especially his/her full name and e-mail address for the purpose of evaluating the contest and contacting the Contestant if a prize is won. The Contestant acknowledges that his/her provision of the aforesaid personal data is voluntary and that consent to the processing thereof can be withdrawn at any time, without cause, either in a written, registered letter addressed to the Organizer at the Organizer's address or in an e-mail forwarded to the Organizer's contact person. The Contestant acknowledges that Act No. 122/2013 Coll. on Protection of Personal Data, as amended, ("Personal Data Protection Act") gives the Contestant the right, in particular, to refuse to provide personal information, to withdraw his/her consent free of charge at any time, and the right to be given access to his/her personal data and the right to change this data, block it, dispose of it and the like. The Contestant is aware that the Organizer is required, in processing the Contestant's personal data, to proceed in accordance with the Personal Data Protection Act and that, as a data subject, the Contestant has the rights specified in detail in Section 28-30 thereof. Such consent is granted by the Contestant until the Contest ends.

#### **VI. Final Provisions:**

1. The Organizer reserves the right to make final decisions about all matters relating to the Contest. The Organizer is likewise entitled to change, shorten or extend the Contest Period and either to cancel or change the rules of the Contest. Any changes in the Contest rules and/or conditions will be announced exclusively in writing and in the form of consecutively numbered addenda, and such changes in the rules will be published on the Organizer's website, whose URL address is [www.visitbratislava.com](http://www.visitbratislava.com), and also on the Co-organizer's website [www.du.esn.sk](http://www.du.esn.sk).

2. The Contest results are final, with no option available for Contestants to appeal.

3. Contestants may not exchange prizes for their cash value or for another prize, nor may the Organizer be forced to enter someone as a Contestant or for a Contestant to seek the recovery of a prize through the courts.

4. The Organizer is not liable for any damage caused to a Contestant as a consequence of the Contestant's participation in the contest or in connection with winning a prize therein.

5. The Organizer is not responsible for any technical problems in the electronic transfer of data.

6. The Organizer reserves the right to decide at its sole discretion on all matters relating to the Contest, without giving any reason for the decision. The Organizer hereby assumes no commitment to any Contestant and Contestants are not entitled to any benefit or consideration from the Organizer other than what is specified in these rules.

7. By participating in the Contest, all participants give their consent to these rules and undertake to comply without reservation with them.
