

COMPETITION RULES

The purpose of this document is to explain the rules of the competition Bratislava #Hockeycity (hereinafter referred to as "Competition"). These rules may only be amended in the form of written amendments.

The event organizer:

Bratislavská organizácia cestovného ruchu - Bratislava Tourist Board, registered office: Primaciálne námestie 1, 814 99 Bratislava, Slovak Republic (hereinafter referred to as "Event organizer").

I. Date and place of the competition:

1. Duration of the Competition – 10th May, 2019 00:00 AM (midnight) to 16th May, 2019 11:59 PM including (hereinafter referred to as "Duration of the competition") in the territory of the Slovak Republic (hereinafter referred to as "Venue").
2. The Competition itself takes place on the internet on the website Instagram.com (hereinafter referred to as "Instagram").

II. Competition participants:

1. Only a natural person over the age of 18 (hereinafter referred to as the "Competition participant") may become a participant in the competition.
2. The people who are employed by or are in some form of employment relationship with the Event organizer, companies and agencies cooperating with the Event organizer, as well as persons close to them are hereinafter banned from entering the Competition. Persons close to the above-mentioned entities are described in a greater detail in Sections 116 and 117 of Act no. 40/1964 Coll. of the Civil Code, as amended (hereinafter referred to as the "Civil Code").
3. Persons who do not fulfill the conditions for participation in the Competition or acting in breach of the Rules will be excluded from the Competition. Even if such a person fulfills the conditions for winning, he/ she does not become a winner and is not entitled to a prize. In this case, the prize is forfeited in favor of the Event organizer who is entitled to give it to the next person in order or use it for other marketing purposes. The Competition participant will also be excluded if the Event organizer discovers or suspects fraudulent or unfair conduct on the part of the Competition participant.

III. Prize and its handover:

1. Prizes:
 - 1x weekend stay (2 nights) in 4 * hotel in the center of Bratislava with breakfast for 2 persons, plus dinner, plus wine tasting
 - 1x stay for 2 nights in a double room with breakfast at Hotel Barónka
 - 5x gift voucher worth 50 EUR to be used in Houdini Restaurant at Marrol's Boutique Hotel, Bratislava,
 - 10x Bratislava CARD valid for 3 days for 1 person(hereinafter referred to as the "Prize"). The winner will receive 1 prize.
2. The prize will be delivered to the winner in the form of a voucher to the e-mail address the winner notifies to the Event organizer after the winner is announced.

3. The fact that the Competition participant won the prize will be announced to the Competition participant within 7 working days after the draw has been made via Instagram message and comment under the corresponding photo. The message may include more details and instructions regarding the takeover of the prize. The winner is required to respect such instructions.
4. In the event that the winner fails to confirm the receipt of the prize within 7 days of the announcement of the competition results or fails to take over the prize according to the terms and conditions agreed in advance, the prize shall be forfeited in favor of the Event organizer.
5. In case of doubt about the right of the Competition participant to participate in the Competition, the Event organizer reserves the right to request the necessary documents from the Competition participant (e.g. ID card in order to confirm the Competition participant's age). If the Competition participant fails to submit the required documents on request, he/she shall be excluded from the Competition. In such a case, the prize shall be forfeited without any compensation in favor of the Event organizer who is entitled to award it to another Competition participant or use it for other marketing purposes.

IV. How the Competition works and determination of winners:

1. The Competition participant enters the Competition by taking a creative photograph or making a creative video with a promotional item of the Event organizer (T-shirt, fan glove, hockey scarf, etc.) and sharing it on his/her Instagram account with the hashtags #hockeycity and #visitbratislava. The photo or video may not be deleted from the Instagram profile of the Competition participant prior 31st May, 2019.
2. The Competition participant enters the Competition at the moment of fulfillment of the above-mentioned conditions.
3. By participating in the competition, the Competition participant agrees to the Rules and to the provision and processing of personal data in the scope of the photo / video shared in the Competition on the Instagram including name, surname and e-mail notified after winning the prize.
4. In the event that the photo / video contains personal data of other persons than those of the Competition participant, the Competition participant guarantees the consent of these persons with the processing of their personal data to the extent specified by these Competition rules; otherwise, the Competition participant shall be liable for any damage in connection with the Competition suffered by the parties concerned.
5. The Competition participant may participate in the competition repeatedly.
6. Determination of winners:
 - a) 17 prizes are awarded in the Competition (Article III., par.1 of the Rules)
 - b) There are to be 16 winners who will be determined by a draw made by the Event organizer. This draw will take place at the end of the Competition and will include all Competition participant who have validly entered the Competition in the manner specified by these Rules.
 - c) The Competition is projected to have 1 winner who will be determined by the Event organizer (the most creative photo or video).
 - d) The Competition participant may win only one prize for the entire duration of the Competition.

V. Processing and protection of personal data:

1. By participating in the Competition, the Competition participant grants the Event organizer permission to process his/her personal data in the scope of the photo / video shared in this Competition on Instagram during the period that ends on May 31, 2019 including name, surname and e-mail and e-mail notified after winning the prize. The Event organizer is the operator of the personal data. The operator's contact person is pr@visitbratislava.com. The personal data are processed in order to organize the competition and for marketing purposes. Legal basis of processing: consent of the data subject to participation in the Competition. Retention period: no later than 31st May, 2019.
2. The person concerned has the following rights:
 - a) the right to require access to personal data relating to him/her (right to obtain confirmation from the operator whether personal data concerning him/her are being processed, the right of access to such personal data and the right to further information under the GDPR);
 - b) the right to rectify personal data (correction of incorrect data and completion of incomplete data);
 - c) the right to delete personal data and the right to limit the processing of personal data;
 - d) the right to object to the processing of personal data;
 - e) the right to portability of personal data;
 - f) the right to withdraw consent to the processing of personal data at any time;
 - g) the right to file a motion to initiate proceedings on the protection of personal data with the Office for Personal Data Protection of the Slovak Republic.
3. The provision of personal data is a contractual requirement of the operator. Consent with the processing of personal data is necessary for carrying out the competition. Failure to provide personal data will result in the inability to participate in the competition.

VI. Final provisions:

1. The Event organizer reserves the right to decide definitively on all matters relating to the Competition. At the same time, the Event organizer is entitled to change, shorten, extend, modify and revoke the rules at any time. In the event of changes in the terms and conditions of the Competition, these will be done exclusively in writing in the form of numbered amendments, and such changes to the rules will be posted on the Event organizer's website www.visitbratislava.com.
2. The results of the Competition are final. The Competition participants have no right to appeal.
3. The exchange of prizes or the payment of cash payments in exchange for material prizes, as well as legal enforcement of the participation in the Competition or the collection of prizes by legal means by the Competition participant is not possible.
4. The Event organizer shall not be liable for any damage incurred by the Competition participant as a result of his/her participation in the Competition or in connection with the prize won.
5. The Event organizer shall not be liable for any technical problems in the transmission of data by electronic means.
6. The Event organizer reserves the right to decide on all issues related to this Competition at its sole discretion and without giving any reason. The Event organizer hereby does not assume any further obligations towards the Competition participants and the Competition participants

are not entitled to any other performance from the Event organizer other than that specified in the Rules.

7. By participating in the competition, each Competition participant accepts the Rules and undertakes to comply with them without reservations.
8. This promotion is in no way sponsored, endorsed or administered by, or associated with, Instagram.
